US Attorney John Durham,

I am a witness against the Criminal Organization you are investigating in regard to the origin of the Trump investigation. I have repeatedly reported the long story of how I accidentally infiltrated this criminal organization. I never get a response. Please be advised that the racket John Hubbard and others keep trying to advance was a sting on my part and very well documented as a last resort to STING Sally Yates who was illegally attacking me. I myself am under a fraudulent FISA warrant that she set up as a part of the racket. The fact is this criminal organization was set up only as a heist; a FISA warrant used to pillage the national treasury. That's all. She had been doing this habitually, using her authority to set up Rackets, the kind that often lead to murder. She approached me, drugged me, and proposed some sinister action and I refused. She did it as a favor to my mother in law, her transcription fixer. After I rejected her she told my mother in law "no way, he's not the guy for the job"- that was just from my answer to a test question. Not only did I not want anything to do with her but I told her I would bust someone who tried to sell me stolen equipment. Problem is she was caught when someone who saw us together called me the next morning and began to remind me of what happened the night before. I was getting wise and she got wicked manipulative and forceful executing a heinous crime to frame me if I came forward, but I still didn't know who she was or what her game was.

That should make me a star witness for you and I am quite willing to testify against this criminal organization. I came up with the plan to sting her after being attacked for 9 months and having my child abducted by her for that time. I had no idea until she approached me through a mutual acquaintance that I would be taking on a group of criminals that was planning to overthrow our government. She made that clear after I was executing the sting. I also learned that I had been drugged with Rohypnol before I executed the Sting. It has been a long harrowing twisted nightmare since I first met her and I have done my very best to collect as much evidence against this criminal organization as possible. It has been ten years since this started. I've refused to cooperate with the racket far more than most ever could while being compelled by a team of corrupt spies.

while some of my most effective testimony may sound a bit far fetched at first there is a freight train of solid evidence that supports it. The mutiny against Trump was something she told me she would do in 2009 if he won the nomination. Her statements are vicious and there are many of them. There are also more witness. I know who some of them are. Most important there is a recording of our conversation most likely in the hands of John Huber, it has been in the hands of other's before. They keep trying to remind me of my commitment and all they do is remind me that I stung them. They last spy group I caught was obviously clueless that I had told the previous spy group it was a sting. Not only has the recording been in more than the hands of those federal agents, but it was made with a few people present. I have a real good idea of the ones that were not present and did not identify themselves.

I am being abused horribly each day due to this fraudulent FISA and I need relief and protection. Not only have my attempts to report and find attorneys been obstructed but the challenge of reaching the proper authorities in a big city is also a hindrance. Parking for my van with high clearance and it's length is a major challenge to simply walking into the proper authorities. I have had multiple FBI and secret service agents obstruct my case and threaten me in my past physical visits to DC and other FBI offices.

I have been instructed to leave town by secret service agents and ridiculed and harassed by some FBI agents. I have little trust for the FBI, CIA, etc. due to my past experiences. I am respectful and unarmed other than for typical camping equipment (ie. bear spray and fishing/pocket knives.) Make no mistake, I will not pose any physical threat to law enforcement and expect to be treated with dignity and respect in return. I am not psychotic and never have been despite the claims made by Sally Yates family and those under her authority. My civil rights have been violated beyond the scope of imagination but I still expect them to be honored as I seek to assist the proper authorities in investigating and prosecuting the criminals who formerly were the proper authorities! I have sought to write an accurate and effective report on my harrowing 10 year long experience and have come up with a few attempts as well as one recently. All have been honest attempts at the truth, some consideration has been given to let my natural playful and jocular demeanor show, this in no way is fiction and anyone who tries to discredit me as I am forced out of private life and wish to be appreciated for some remnants of my former extremely jocular personality will be called on it. Summarizing my experience is a bit of a challenge due to the long duration covered and the complexity of my understanding (often events were understood by me long after they happened as my attackers used Rohypnol). I will be making every attempt to contact reputable watchdog organizations and attorneys for my protection and at the same time trying to contact the US attorneys handling my case. Whenever an officer asks me if I have been deemed delusional or otherwise psychotic or ask me to talk to a psychologist or psychiatrist I will not work with them any longer. I do not even remotely fit the bill for psychotic and that behavior will be considered an act of bad faith. I am happy to talk about my experiences with the past criminals who pushed this issue and my abuse under the authorities who sought to exploit me using such accusations.

I will submit this two page summary first and make available my previous attempts to put my experience into writing also. I have a safe full of evidence, a backpack with critical evidence, a lockbox with important evidence. My person belongings are mixed in with evidence and evidence is deeply imbedded in my personal belongings. I will not hide any evidence from the proper authorities acting in good faith and there is no need to dismantle my Van. I live in my van and great effort has been made so that I can do this. I will be happy to assist all law enforcement in accessing my property and devices to expedite the process and preserve all evidence. The best way to find me is by my phone 801-989-4460
