

Dear Senate Judicial Oversight Committee,

6/26/2019

This is a two page report. The rest is a log of the evidence and additional information. I am Ferris Broxton Jr, a whistleblower who has been obstructed from contacting you for many years by FISA abuse. In other words, my reports are intercepted under a fraudulent FISA warrant. I am an eyewitness against the criminal organization, including FISA judges, within U.S. intelligence using US assets for criminal actions. I am witness against many of the top FBI, CIA, and DOJ officials specifically under investigation in the origins of the Trump investigation. I infiltrated this organization accidentally while investigating who attacked me and collected a massive amount of evidence to support my claims and aid in the prosecution of the criminal actors within FBI, CIA, NSA, and USDOJ. Unfortunately, the conspiracy I agreed to (as part of a sting operation I had planned for whoever approached me), included a FISA warrant which I didn't understand at the time. After being drugged with rohypnol, I executed the sting. I was drugged, and overwhelmed realizing that the criminals who had attacked me were planning to take over the government by any means possible. All my attempts to expose them from the beginning, even before this, had been obstructed by U.S. intelligence. This harrowing nightmare continued as I was framed and held in Sally Yates family run county and Jail in Jackson county Georgia for 3.8 years without bond nor trial. Immediately, my cellmate was used as a "cutout" to begin to remind me of my commitment. Sally Yates son, Ryan Yates, would walk him to the nurse, her daughter, for his insulin shots. He would come back and recite carefully chosen parts of the conspiracy (really my "sting") which nobody was onto yet. Although I had consistently shown effort to expose them, I had not yet recalled that I executed the sting which I planned when someone told me that I would be approached unexpectedly, to think about what I wanted. I had only the slightest clue at that point that the guard was related to Sally Yates; no clue that the nurse was her daughter.

In the course of the conspiratorial "agreement" Sally named numerous people who would have to cooperate and sign off on a massive fraudulent settlement. I was forced into this from the beginning because Sally owed my mother in law a favor for fixing transcripts for her previous heists. The top officials who are cooperating with this and other parallel fraudulent CIA, NSA, and DOJ operations are doing so to pillage the treasury and exploit the victims...they are the group that Sally named. She also named people who I should "avoid" as even while I was stinging them I was careful to say I would go to all the proper authorities. The folks most likely to conspire were often named by first names only but also identified by other key positions, riddles, characteristics, and actions they would take to identify themselves.

Sally was able to predict who the most likely occupants of key government positions would be based on who was appointing and who was qualified. She quite accurately named many of them. She had an analysis in 2009 that the next change of power election would likely be between Trump and Clinton and clearly stated several different ways that "[they] would do whatever necessary to oust Trump if he were the candidate. Clearly they didn't control Trump. Other disturbing statement from her included that she didn't care at all about anyone but "her people" and that she was going to take whatever she could while she had the opportunity. Clearly they have. As recent as three months ago, Jackson county GA paid \$400,000 in ransomware, no doubt to US spies... I.T. hackers. If I hadn't watched their work for years I wouldn't state that so boldly!

I have repeatedly documented my e-mail, snail mail, phone calls, faxes, etc being intercepted and otherwise obstructed. I have driven across the country four times now so I can deliver reports to the proper authorities in person and they are rejected or intercepted by someone who is controlled by US intelligence. I documented my last visit to DC well when I gave a report to Devin Nunez secretary while he was chairman of the oversight committee. Her response was "no, you can't set an appointment to meet with him, this will be given to intelligence and someone will contact you." Nobody contacted me but I did have a party (mostly strangers) waiting for me when I got back to Florida waiting to take me out of the country as discussed in the racket Sally Yates set up!" I had to abandon my residence then as the criminals in the spy community obviously gained control over the people who controlled my residence. This continues everywhere I go.

Your system is dysfunctional as it depends completely on US intelligence to operate with integrity instead of putting the elected officials in control. In fact, Sally had implied and demonstrated that many lawmakers are controlled and/or manipulated by her criminal organization. My experience shows the same.

Critical to prosecution are "means and motive" Sally's means and motive are distinct beyond her position. Sally Quillian Yates comes from a long line of Federal power that has been partners and intermarried with the Richard Russel Family. Russel controlled the Senate and chaired all the intelligence committees. This small area in Georgia, the Piedmont Judicial circuit, has been home to a group that has had control over US intelligence since its inception. The long practice of paying off everyone that needs to cooperate one of these heist is devastating to our economy and justice system and is very much the motive for anyone who has been involved to cooperate with the attack against any president they don't control. In some of my earliest videos exposing corruption, I clearly stated that I was a whistleblower exposing an issue that appeared to be an issue of National Security. I identified myself as Ferris Broxton with Ferris Broxton investigating, clearly showing that I suspected that a group of FBI agents were attacking our national security.

I should point out that when those under Sally Yates framed me, I had a website set up (357 cletis on YouTube) exposing the corruption I had encountered to that point; many clear aspects of a false arrest, fraudulent police reports, and my child being taken without any claim that I was a threat to him). I was "kidnapped" by Jackson County Sheriff's deputies while putting out thousands of CD's exposing the rampant corruption in the Piedmont circuit. This happened after I was attacked in my back yard, held with a gun to my head and told not to look at the officer while rohypnol was splashed on my back. My neighbors reported the assault. I made several videos and put them in the public domain including one recording of a neighbors saying he saw the assault rifle the officer who attacked me carried. Another video had a clear statement from another neighbor who called in the attack since they were obviously hurting me. I was never able to get surgery from the injury that followed.

The following is a sample of the evidence I have in my possession and guard it desperately, often having to carry it on my back.

1. Evidence that certified mail to Rudi Giuliani, Jay Sekulow, and Robert Mueller stating that I am a witness against the president's accusers (as described above) has been intercepted, obstructed, and otherwise sabotaged. This, which is one of my later letters (dated 8/22/2018) never received a response from Mueller. The ACLJ response appears to be a ghosted response

declining to pass it along to Sekulow without any name on it. Giuliani's letter was returned as "undeliverable" and I have the certified mail piece unopened.

2. I have evidence of a letter I sent to the US intelligence oversight 4/28/17 documenting that I was a witness against Sally Yates criminal activities with corrupt US intelligence agents.
3. I have evidence of multiple obstruction's in my attempts to reach the watchdog groups that are exposing this corruption. The latest three were this week and involved E-mail to Judicial watch; three different from 3 different days sent from 2 different libraries. It is quite frustrating to hear daily discussion on the radio about what the investigators are trying to find when I have it!
4. USDOJ complaint to John Durham's office faxed 6-20-2019 then recordings of someone claiming to work there telling me they don't have a written complaint from me.
5. 6-26-2019 Recording made of my attempts to get an appointment at Bill Barr's Office and video of officer E. Miranda after he told me he could not help me get an appointment nor take a report from me despite my claim that mine were intercepted. He did ask me "you investigated who?" but I don't think I told him I investigated anyone. Looks like another loud message from the crooks. The spies knew where I was going long before I got there...I searched the location on my phone after planning a trip to DC. Officer Miranda waiting for me!? They can give him any ID they want but I got a little video in case that's not his real name. I have a message for anyone who thinks catching the government crooks attacking me, our president, and this nation is a crime: I will testify against you before man and God.
6. 6-24-2019 I made a report as a whistleblower the IG in response to obstruction from someone in the phone claiming to work at John Durham's office... also videotaped
7. I have certified copies of my case from Barrow and Jackson counties. The Jackson county file was missing important information like who said I was unfit for trial (that would be the nurses job- Shelly Yates) so I left the 2 Barrow county envelopes unopened.
8. Through my own investigation I have discovered that the Superior court judge who handled my case had employed my former mother in law as his stenographer and driven his car shortly before my arrest. I discovered there was a short private trail between their houses and recalled witnessing Sally bring her transcripts that needed fixing and the health elixir the county editor published as "a suspicious common thread between a few unrelated bizarre complaints." The health elixir with varying taste and consistency was for administering Rohypnol and I recall Sally telling my mother in law that "this on is the original formulae and this one is the new don't confuse them."
9. 6-21-2019 I have a message sent to the USDOJ attempting another avenue to report the same thing.
10. I have my original demand for a speedy trial dated July 31st 2009 for the original Barrow County charge.
11. I have a copy of summons for the same original case for calendar call April 7, 2014. They kept me in Jackson County accused of violating a protective order/aggravated stalking bases on the bogus Barrow county charge. After being threatened with a return to the mental facility and with a "Sell" order (being held down and given shots ----to melt your brain?) I signed a plea to a single count of violating a protective order. I MODIFIED MY SIGNATURE TO DURESS as much as possible without being detected and still have the form.
12. I still have the titles to my lost toys and hot rods and picture of my high tech and vintage gun collection the Barrow county Sheriff confiscated and never returned.

13. I have my patent design records which this manipulation by spies has caused me to lose.
14. Record of the destruction of my reputation- mugshots and 1st computer search results
15. 3/17/2017 Copy of fax of letter written to Jay Sekulow documenting that I suspected FBI obstructing his witness.
16. Daily drivers logs and names of planners and their myriad of attacks on my employment, many of the names (spies) were given to me by Sally Yates, this is a long solid documentation of the USDOJ "color of law policy" of attacking whistleblowers and opponents.
17. I have evidence that the spies in my case were able to manipulate other people into "helping" me who I have known in order to make it look like I masterminded the racket. Clearly the other similar rackets I discovered would clear me of that, but to be sure I repeatedly abandoned my family and friends to prove that I want to expose the criminals not conspire with them. I have found and have evidence that people "helped" me (they helped advance Sally Yates racket but it only hurt me). I want these victims protected and assured of immunity from prosecution for cooperating with corrupt government officials.
18. What appears to be a fabricated credit report which is the best I can find about who the Government has recreated me as.
19. A post it note from 6/25/19 from Julian at the US senate Judicial oversight committee who wrote down the whistleblower address I'm sending this to (whistleblower@judiciary-rep.senate.gov). Julian got red in the face when I patiently and repeatedly asked if he understood the nature of the problem, specifically that spies were obstructing my E-mail. He never acknowledged that he understood my concern only insisted that they would get it. He further stated that they (he) could not take any reports there. I couldn't even hand them to him!
20. I have my notes from when I spoke to Nicholi (female) at the Senate select committee on intelligence on 6/26/19. She seems bright and clearly understood but said they could not help me that I would have to get my senator to help me.
21. I have evidence that is likely classified of a spy, who Sally Yates named, who was working for a company I believe is owned by a Utah lawmaker. So it looks like the spies are infiltrating the lawmakers' companies and have the ability to manipulate their assets and blackmail them. Looks more like a vicious circle controlled by the criminals everywhere I go.
22. I have many other reports and recordings of my attempts to expose this criminal organization that go back ten years, but this is far more than enough for the proper protection, relief, and investigation to begin.
23. I have evidence that Sally Yates daughter, A caught superior court judge, and those under Sally Yates authority conspired to hold me in a mental facility for 8 months of the 3.8 years I was held in her family run jail despite my obvious sanity and refusal to behave "insane." I also have evidence to show that the FBI claims that I wasn't there! I would love to testify against the CIA agent who posed as my evaluator there... and his brother who later acted in my case. I should be able to give his name but I am trying to respect the unfair process I'm forced to be tormented under. They denied me access to my medical records but I hid my wristband and still have it. I also have a driver's license that they allowed me to get while held as "unfit for trial" with the address of the facility on it! Corrupt FBI and CIA can do whatever they want and this issuing of a drivers license was clearly in conflict with itself! Now I have a CDL driver's license with doubles, triples, and hazmat...and the address of a residence of the FBI agent who should be in control of

my case! Her husband employed me. Though they left little evidence of their marriage, I do have some. This would prevent her from having to testify against him and visa-versa. This goes very much to the heart of the problem, far too often FBI only helps a victim if they can exploit them and this is what they did to me. They would let me work but only if I restored trucks for them, stealing my hot rods wasn't enough. Still, they would only let me work so much. This Prevents me from making enough money to get free and expose them. It also advances the racket because it keep any proof of my income low. Still, they went through extended spells of allowing me to work freely so they could collect evidence of my true capability. They want me to take a massive settlement claiming I'm unable to work and they want to be able to blackmail me. Remember, this racket is conducted by people who study and prosecute human exploitation cases. The ability of a team of federal agents to control someone is sensational. That not be a good sensation. While this plays out, I demand immediate relief at the rate I could earn income if not "spied" on (truly sabotaged)! I have been a slave to these goons and all my attempts to escape are still obstructed! If this demand fails to be met I will demand 10% of the full budget of the responsible agencies under the RICO laws as well as the sum of every offenders' assets allowable under the RICO laws and their full prosecution. That means anyone and any organization that delays my case anymore at all. I have been attacked for 10 years now and still while the group doing it is under investigation! If the top leadership can't do any better than this then they are the Perps! One of the ways I have planned to stop the racket is to relocate and inform the US attorney in advance that the recording of me is a sting so that he will not go along with the racket as all previous have. How can I do this if I can't meet with a US attorney due to FISA abuse? Ferris Broxton Jr
