

Log of evidence 6/26/2019 (first portion to align with paper evidence from report to Judicial Oversight)

1. Copy of the letter sent to Trumps' attorneys and special counsel Mueller that I was a witness against Trumps' accusers.
 - a. Copy of proof that item 1 was sent certified mail to Mueller, Giuliani, and Sekulow
 - b. Copy of the returned certified letter marked undeliverable – related to item 1.
 - c. Copy of the letter that appears to be a fraud imitating the ACLU – no signature or action – related to item 1. Sept 26/2016
2. Copy of letter to intelligence 4/28/2017 stating I was a witness and detailing crime in great detail. This contains sensitive information so just the first page is here for proof. This should be the same letter intercepted by intelligence at Devin Nunez office. - no response
 - b. Copy of same letter faxed to Jay Sekulow- appears to have gone through but most likely intercepted by spies.
3. Copy of e-mail to Geoffrey Lyon @ Judicial watch obstructed 3 times over a period of several days and sent from two different locations.
4. Copy of complaint faxed to John Durham's office 6-21-2019
 - b. a separate similar complaint filed online with John Durhams office 6/24/2019
5. The report I brought was rejected by this officer at William Barr's office on Pennsylvania Ave Typed 6-24 -19 and much effort made to deliver it 6-25-2019; it is entered into my evidence log here. Video- no transcript at this point. May be used by authorities to identify if necessary
6. On or about 6-24-2019 Complaint to the IG that someone claiming to work at John Durham's office was obstructing my attempts to reach him.
7. These are several pages long and I have not made copies of the Jackson county certified docs nor opened the Barrow county certified docs. The Jackson county certified Doc's appear strategically mishandled- plea page is not certified. Barrow county Doc's should be opened in the proper arena to expose if they are also missing critical information such as who said I was not fit for trial. Who recommended the evaluation. Where are the recusal papers for the prosecutors. The judge appears to be just plain caught.
8. Evidence of connections between Superior Court Judge David Motes and Sandy Saxton would be in the yearbooks from Jefferson High-school where Pam Dodd Motes was Tabitha and Holly Saxton's teacher while Sandy was neighbor, friend and room-mother. Then Jackson county court documents/ depositions/ and witnesses would show Sandy Saxton was Judge David Motes stenographer. Statements from Motes' neighbor and Sandy Saxton to Me, Ferris Broxton, helped me make the connection that Sandy Saxton was driving David Motes car shortly before I was arrested, while they were setting me up.
9. 6-21-2019 message to the DOJ using another avenue since it is clear that I have had multiple obstructions, I have made many reports to erase any doubt of my intent or what is really going on.
10. July 31st 2009 Demand for fast and speedy trial after I was arrester for a non-crime and charged with simple battery against my then wife. This is solid proof that I did not understand or intend to cooperate with their racket!
11. April 17th 2014 Copy of summons for the same charge that I filed for a fast and speedy trial on 4 years and 8 months earlier! Clear evidence that I still was not cooperating with the

- racket. They could not hold me on this misdemeanor as I had paid bond on it and I refused any plea. The charges were null pros eventually by an attorney I paid to take it to trial.
- a. This is the plea form for a single charge of violating a protective order. Notice I modified my signature as much as possible without detection to show Duress. I had been threatened with a very long stay at the mental facility and a "Sell" order of being forced medication at this point. There was a man at that facility held for 26 years from my circuit. He had been there longer than anyone could remember and I feared they would make me like him... he was truly a mental patient and a menace.
 - b. Nolle Pros for the bogus charge of domestic violence that the entire case was based on. Still handled by Judge Motes December 17th 2014 almost 5 ½ years after my arrest! My original is certified with stamp and signature.
12. Not necessary for proper authorities or media to begin investigation
 13. Not necessary for authorities or media at this point
 14. What false arrest does to someone reputation- mugshots; your first search results.
 15. 3/7/2017 copy of fax of letter written to Jay Sekulow documenting my reports of Spies obstructing his witness.
 16. This is a massive pile of evidence, daily schedules and notes that can't be readily duplicated or handled.
 17. This is sensitive information regarding other victims manipulated by corrupt spies. I have no intention of causing these victims any more trouble than necessary. I think each one has a valid claim against Sally Yates and others who orchestrate these rackets.
 18. Although this appears to be a fabricated credit report, It has sensitive information. Critical here is that when these criminals force me to the brink of financial destruction I did everything in my power to survive and work and was obstructed. Toward the end I attempted repeatedly to file bankruptcy and that was obstructed also. Any and all claims against me financially would be the responsibility of the corrupt spies. Racketeering cost our government far more than anyone would estimate at first. It is an incredibly inefficient way for the purps to get a small amount of money in their pockets. The ones at the top who take a portion to sign off on a check are the most flagrant violators and aware of this.
 19. Post it note, bold is the writing from Julian, the rest are my notes.
 20. My notes ---Can't find this note (from yesterday 6-25-19) at this point.
 21. I wish I could make this public. The man I knew with the same name as the spy was an Eagle scout and a very large man.
 22. This is a pile of information and evidence that I have not yet organized well yet, but additional information not corresponding to the current Judicial oversight report begin at number 24
 23. This photo and article reminded me of one time I heard another Jackson county jail guard call Ryan "Quill." His nametag was simply "Yates." He was promoted far faster than anyone else in the system. The nurse was "Michelle" on her name tag. She made enough subtle comments for it all to fall in place when I found this photo.
 - a. The CIA crook or other undercover actor at the mental facility had a very similar name as a friend of mine. Both had a serious knee problem and a very big brother. Sally was sure I knew someone and tried to manipulate anyone to help me if it looked like I knew them. She wanted to make this appear to be my plan.

- b. Copy of the driver's license I was issued at the mental facility. Proof that they wanted me to cooperate in the avenue of moving and getting a different job as they have channeled me to do. I didn't understand at the time. I made the face to show that this was a picture taken while in a very disturbing situation. I thought they were going to kill me, toss me in the middle of a wreck and claim I never was at the facility, with the license on me. If I were able to get the license and escape I wanted it to show where I was being held, I didn't think they would put the address of the facility on it. I may have done that without them being able to control or notice. Still can't believe they left me with such a great piece of evidence. If you're not fit for trial, you're not fit to drive a car! I have included my other licenses to show that I did not immediately go into CDL work. I wouldn't borrow money for Truck driving School. I had a hard enough time surviving at first and only after my employer began to heinously exploit me (no doubt manipulated by spies) did I look for other employment and was channeled where they had a setup waiting for me. CDL driving was one of my preferred backup employment choices. Also on this page is a copy of my identification bracelet that I carefully saved from the Psychiatric ward. It is stuck to a business card and documents one of the psychiatrists I'm a witness against. The business card is quite relevant also and is a reminder of a massive lead to another case like mine that settled and made a couple miserably rich. The man was forced to give a presentation where I was present... it was a hint that someone in this room had been selected to go through what he went through. Now it is more obvious than ever that presentation was for me. This criminal organization has been doing this for a long time.
24. This is a motion to dead docket from the prosecutor 8-18-2014. I likely received this by mail and a certified copy should be in the unopened certified packet.
25. This is a very serious threat that I was able to videotape from a spy in Salt Lake City who came over my CB. I duplicated the video by videotaping one camera with another and transcribed the threat without any equipment. With filters and amplifiers this could likely be completely recovered and clearly heard. I reported this and other racketeering to the FBI in Salt Lake City. They took the report and said they had no interest in it and refused to give me a receipt or the agents name. I made a video at the parking area to document my complaint and was run off by another agent...on my camera! I took careful notes about his appearance later and could identify him for the prosecutor.
26. Another documentation of an e-mail attempt to reach Jay Sekulow which failed...they all fail. Looks like someone who is spying on me accessed my account here. I've seen this too many times.
27. Here is another report I sent via computer to Jay Sekulow May 8th 2017. Anyone in his office should have recognized this as a critical communication in favor of his case(s). It probably never reached him.
28. Here is a letter written 5/9/2014. I believe I delivered this to the FBI office in Jacksonville Florida. This is just a short note since I had been pressured to stop reporting the full story or lose any claim or ability to resolve my situation. I have no doubt that when I pull out more of my computer files and review video from that time period this will prove to be just a single piece of the evidence I saved from daily manipulation obstructing me from getting anything resolved.
