

Trump's (America's) best Witness document started 1-2-2021 by Ferris Broxton Jr revised 3-1-21

This report has been rewritten to be more clear, using terms and current cases that the American public are now familiar with such as FISA abuse (spying [sabotaging] citizens with teams of US Spies). The purpose of this is to aid the American citizens in understanding how and why Trump has been cheated out of an election as well as confronting ND US attorney Drew Wriggley, CIA director Gina Haspell, and FBI director Chris Wray for silencing Trump's best witness. Truly, your government has been subtly overthrown; I joined the group that did it in order to catch them. This document will explain everything you want to know. If you finish it and it doesn't fit together like a complete puzzle, read it again, look up the cases I refer to. Tucker Carlson, Hannity, Mark Levin are crying out that the presidential election is a fraud! You need to understand why Socialism is preferred by the people who did this, they are controlling many of your lawmakers. Even as I reread and update this document 1 month after that was written the reporters listed above are no longer screaming that the election was a fraud. Why?

Because the FBI director Chris Wray made a public statement that the FBI's primary mission was to ensure confidence in the presidential election process. In this same short period, our president has been silenced by social media and anyone who uses social media to expose spy agency corruption and election fraud will be silenced. Well, if you bow down to socialist criminals like these stealing your first amendment rights, then you don't deserve to live in this country. The bold actions and sacrifices made by our forefathers and ancestors do not guarantee freedom will continue. Talk, use your resources, and take proper and legal action. We are rapidly losing our right to free exercise of religion, the religion of our forefathers. The men who forged our founding documents were Protestant Christian as a group who had fled the establishment of Catholicism in Government. There was one Jew, one Catholic, and one agnostic in the group. The right to freedom from "the establishment of religion" in the constitution was established so you don't have to confess your sins to a Government spy who took your money and your confession under the title of Catholic priest! Still not sure? OK, these were the same men who placed the words "In god we trust" on our currency. The God we trust as Christians and Jews says he alone is God; there is no other! Yes, clearly the "freedom of religion" our ancestors died for is freedom to worship Yahweh. Christians believe the Father (Yahweh), the son (Jesus), and the Holy Spirit are one.

I would have left that out, except Sally Yates told me "religion is a tool that is used to control people; there is no god!" You must understand that these people who have overthrown your government are anti-Christ and anti-American. They have used all the tools of the spy agencies illegally to gain control over every lawmaker, reporter, and bureaucrat possible. I know because I joined them in order to catch them after they attacked me, attempting to gain control over me. We live in a spiritual world and these people are controlled by our greatest enemy, but they don't realize it. Most Christian's are very hesitant to be prosecutors or investigators because of what they believe about being judged if they judge others. The fact that our spy agencies are run by Godless criminals should surprise no Christians.

Before I get into my case and how I busted the heads of the spy agencies conspiring to overthrow our government lets start with what you should already know. Sally Yates, as acting US attorney General, got a FISA warrant to spy on Trump. She oversaw the FBI and CIA placing US spies on the president's campaign. Volunteering is an easy way to gain access to an organization. Yates is currently under investigation by John Durham for this attack against Trump from the beginning of his presidency! OK, so now Yates is saying she got bad info from the FBI and that is why she got the FISA warrant; she says it was an honest mistake! No, I went public exposing that she was using FISA to run an organization focused on controlling the government in 2010! I joined and "stung" her and the criminal organization

within the spy community to catch the people who were attacking me! I have the evidence and I know where many other witnesses against Yates can be found! In 2010 I set up a website on Youtube with dozens of videos; evidence of her corruption under the handle "357 cletis." Most of the evidence was taken down in short order and I was held in Jackson County jail under bogus charges for nearly 4 years; never prosecuted. Knowing that the internet authorities would likely take down my videos, I also burned thousands of DVD's and slung them out into people's yards and other places they would be found along with the morning paper. Jackson county GA was run by Sally Yates Family; her brother-in-law Bruce Yates was the Chief of police and county commissioner, her children held key positions in the jail where I was held hostage. As US attorney in the region, Sally Yates oversaw the jail as well as the local, and state law enforcement.

So, I busted Sally Yates. Then I went to every conceivable and proper law enforcement agency with report and evidence but they ignored me. I went to Washington DC and turned in reports to the intel agency oversight committees, judicial oversight committees, and others. I did this multiple times and kept copies and videos evidence of myself as I did this. Still, nobody has contacted me! Throughout Trump's entire presidency the spy agencies have held the evidence and kept it from John Durham and the public! The evidence which proved Obama, Joe Biden, and Yates conspired against Trump has been held by Chris Wray and Gina Haspell instead of being released. I am sabotaged by FISA instead of being protected and brought forward as Trump's best witness. Clearly, your Judeo-Christian President has been overthrown by anti-Christian bureaucrats. My investigation indicates that these corrupt spies have effectively run criminals like Jeffrey Epstein in order to ensnare key politicians who would otherwise be much more effective in exposing the "Russia-gate" FISA abuse against our president.

Here ends the preface to why this case is so important and returns to the previously started document of how, at God's direction and empowerment, I stung the criminals who have overthrown our government.

I am a FISA victim that is currently under a fraudulent warrant which was started as a FBI/NSA/CIA mission to defraud the treasury (FISA abuse). In other words, the FBI and CIA know I'm not a foreign spy (born and raised in the US) but they have sworn I am in order to get a FISA warrant renewed many times to continue spying on me. The object of their mission was a massive fraudulent heist on the national treasury, known as a seal case settlement. My agreement to be the subject of the heist has been clearly revealed as a sting conducted by me, when I saw that God had given me the opportunity and no other righteous choice. So, I've blown the whistle on the people responsible for investigating Fraud, Waste, and Abuse for a policy of Fraud, Waste, and Abuse. They are wasting tax payer money in order to rip off the Treasury and have been for over ten years in my case! Their problem is I won't cooperate because my only intent was to catch and expose the people who attacked me!

As a result, I am a witness against Gina Haspell and Chris Wray for conspiring against Trump. Both stepped into a sting operation I set up by conspiring with Sally Yates in order to catch her after she attacked me using the same criminal FISA abuse strategy she **used to attack Trump. My case started**

long before she attacked Trump and is proof that Haspell and Wray conspired against Trump. My case also explains why Wray and Haspel and Jim Comi have to conspire against Trump. If John Durham interviews me, Haspell and Wray will be exposed for FISA abuse in my case! Their only hope is to get Trump out, so the Durham investigation will slow down and my testimony will be quelched. I know I'm not the only FISA victim other than Trump. I know how to find more but I don't have the finances nor the voice to do so. I am effectively muzzled by the corrupt Federal judge who signed the FISA warrant against me in secret, thinking it would line his pockets. Sadly, just recently, the criminals who have overthrown your government have effectively silenced the voices of many witnesses on social media

In the course of my sting operation, I learned how acting US attorney General Sally Yates used corrupt deep state tactics to control the upcoming leadership of the FBI, CIA, and NSA....but so did you if you were following the NSA corruption when Snowden exposed them! She did it all by illegal spying, mishandling complaints, and utilizing a database of people who were puppets of the prosecutors. First, illegal spying. Well, Edward Snowden exposed rampant corruption at the NSA about the time my case started. You know that unless you have your head buried in the sand or were born yesterday!

Mishandling complaints is what most people don't understand. That means someone files a complaint like I did twenty-five years ago when a steroid raging cop came in my apartment and started a fight. "yeah, I hit your dog, he ran out in front of my car." "I was driving safe and stopped as quick as possible, don't you know there is a leash law?" His dog was fine but he invaded my townhome and raged on me. The only reason I didn't physically defend myself and my property was because someone else had a big gun drawn on him though he could not see that at this point! His life changed when the owner of our townhomes saw him lose control. She fired him from security detail and I filed a complaint with his boss at the local police department. I was encouraged by many when I found out the neighbors were terrified of him and he was selling drugs to the kids next door.

Everybody has seen something like this but when the investigation drags on and the cop goes unpunished, it is because the prosecutor decided to make him a slave. This roid-raging cop was never punished properly but was now a dirty cop under the control of a corrupt prosecutor or investigator sitting on the evidence. A corrupt cop is born instead of fired. Prosecutors who don't fear God do this on a regular basis. They expect to profit much more from having a slave while the statute of limitations runs, longer if they can continue to catch him in more crimes! Prosecute the purp and make the same income? That's old fashion and takes work. No, the moral degrade of our society has brought us to rampant corruption. The longer a prosecutor or law enforcement investigator is in the business of handling evidence, the more they learn how to misuse it for their own vices.

Top Federal prosecutors have responsibility to look into complaints about lower law enforcement. They have a government security clearance that allows them to search powerful websites for information by any subject on any accused individual, accusation, investigation, and even who is a secret agent for what agency and their professional expertise. The higher the clearance, the broader their view. I witness Yates doing this with deft skill, naming dozens of spies and puppets that she could and would use to run criminal organizations

Now, while the capabilities of our 60 billion dollar spy agencies are clear and obvious. When you consider their ability, it should dawn on you that organized crime cannot survive unless they are horribly corrupt! Well, that's another subject for another day. Too many top cops and prosecutors are

mobsters, running organized crime. I caught the big one and the way my case played out it ensnared many more. More important, recognize that many good men and women get into law enforcement with the best intentions but even a false accusation, or single mis-step can lead to a life of corruption if a good prosecutor is not in charge! Corrupt prosecutors and top law enforcement officials must be prosecuted to the full penalty when they are caught!

Clearly, Sally Yates did not act alone. Rather, she told me "We didn't start the fire." The spy agencies 60 billion annual budget has empowered the heads of the spy agencies to grow to the point where Democracy is controlled by a massive spy organization that is allowed to operate in secret. Yates has a legal family history that flows directly downstream from Richard Russel Jr, the nations' historical oversight of all spy agencies; his law firm is still in my hometown where this started; Winder GA...wonder where she learned it?

John Durham's Russia investigation into FISA abuse will net many top intel leadership heads when I am recognized as Trumps best witness. America will have proof that Trump was not only attacked in the election he prevailed in but also in 2020! I joined the criminals who conspired to take over your government after they thought I was caught and controllable. Now, they know I had a well-planned sting operation to bust Sally Yates, who had been attacking me, trying to get me to join her new world order.

What I'm going to be explaining is why and how the FBI and CIA have a video of me agreeing to the FISA Racket sting. This Sting has caught CIA director Haspell and FBI director Wray as well as a multitude of other FBI, CIA, and NSA criminals who abused their position. Their failure to protect me and bring me forward makes them more guilty every day.

Yates chose to bring me into her criminal organization for multiple reasons. First and foremost, she owed my mother-in-law a favor for fixing transcripts from her previous heists. No doubt, other reasons include I'm physically and mentally capable. I was a young CEO for my own tiny company, holding a B.S. in Physics and never having to take another job after graduating as the Dean Student Advisor for my Physics Class at UGA.

What Yates may have missed is that I was selected out of UGA's Dean Student Advisors by my peers to be on the elite F.A.C., handling the Universities Finances. Despite having the lowest GPA of any Dean Student Advisor, I was known for my moral thread. When everyone was cheating, I walked away, and was known for that. I was a champion in Athletics and the people close to me knew I wouldn't touch steroids or any performance enhancing drugs. They knew, that even as a child, I had come to the defense of my family, classmates, and myself, putting several bigger violent adults in the hospital with only a momentary clash. My friends knew it was safe to wrestle and play with me but when danger came they ran to me for defense. Clearly God prepared me for the difficult times I and trials I would face; Sally Yates doesn't know God, she thinks "religion was created to control people;" her words.

Yates could see my legal history, she knew I fought tenaciously, mangled bullies. She may have known that I Investigated, and won against multiple fraudulent accusations...before studying law. I'm a skilled hunter and survivalist, capable of fixing anything; taking apart and rebuilding my vehicles from the ground up, including engines, planetary transmissions, and electronics. I have assisted in building houses from the ground up. I can usually solve difficult problems and avoid others that hinder most

people. All glory to my lord and savior Jesus Christ. Still, I think the primary reason Yates noticed me was because she owed my Mother-in-law a favor.

I was approached many times by Sally Yates friends and family. They repeatedly drugged me with Rohypnol and baited me into their circle. A little reading on Rohypnol reveals it causes anterior grade amnesia, but the memory can often be recovered with proper techniques. In other words, after it is absorbed into your skin or ingested you forget what happened before it was administered and well after. When something reminds you of critical events that occurred while you were under attack you can slowly put pieces together to recall the lost memory.

From the very beginning Yates' plan went awry. In 2009, my sweetheart told me to hurry home, that I agreed to meet with her Mother's friend. We traveled out of town to a nice restaurant. I was miffed because I still didn't want to meet any of her mother's friends and could not recall agreeing to do so. When we were close, I told her that the location was managed by my brother-in-law. My bride made a quick flurry of calls but was not able to change the location because Sally Yates and her battle ax security detail were already seated in the center of the restaurant. I was drugged with Rohypnol in my beverage and woke in the morning to a call from my Brother-in-law asking what was going on. He was alarmed that I could not remember talking to him. The fine details were completely forgotten at that point, but I can recall them vividly now.

I have written many times before on the details of the proposals Yates made at that meeting and incriminating clues I gleaned from that and other meetings. Those references are available but I want this to remain concise and understandable. I will only mention the highlights so I can demonstrate her motive. In response to Yates question's, I told her how I "stung" equipment thieves who approached me with stolen goods. I told her how I was compliant with my labor management following my CPA's tax advice. She told me she owed my mother-in-law a favor, making that a point I wouldn't forget! The meeting ended with Yates telling my mother-law "No way! he's not the right guy for the job." Good! We agree. Too bad, anyone skilled in Rohypnol abuse knows I'm going to recall the drugged event because of the phone call in the morning asking me about it. At this point they all know I'll figure them out and they are working on an expiring clock. They also have other witnesses who are figuring out what they are up to.

At one point, I was attacked by my wife and mother in-law, assisting Yates in a Jeffrey Epstein type attempt to gain control over me. I'm referring to the filthy rich man who owned an island where attractive minor females were used to seduce the nations leadership including Bill Clinton and the Queens of England's son. An island where there was a giant chess board with peoples faces carved into the pieces. Truly, an island where witchcraft was a powerfully financed art. "Pharmakeia," as it is referred to in the ancient text of scripture; controlling people through the use of drugs and manipulation. Blackmail basically; drug them and trick them into a shameful felony then make them perform their finest skills, like lawmaking, to serve the criminals who hold the evidence.

My wife selected remote islands for our desired vacation spots and talked about living...or meeting up out of the country while traveling, but never going further than dropping hints about what she could do. Her attractive mother would take trips and had for many years with Yates inside crowd to the islands. I later learned she was Yates' transcription fixer; even witnessing Sally Yates hand her both transcripts that needed fixing and bottles of the health elixir they used as the vector for Rophypnol, stating "this one, (this bottle) is the special one."

I was clueless, I didn't know who was who or what they were up to. I was just minding my own business, visiting the out-laws. They knew I would figure it all out in the long run, they just didn't think I'd be the one guy to slip their trap and say "no-thanks" to the rich mobster life.

This is how they tried it with me.

The attack against me began gradually with a free gift of an expensive health elixir. One of the worst attacks occurred after a dose of Rohypnol was administered to me in an unsuspecting fashion. I was awakened late at night my marital bed, in my castle, by my lovely wife, compelling me to fulfill my marital duties. I was paralyzed on my back with a soft undetectable blindfold on and an I.V. in my foot which was used to bring me in and out of consciousness. I had no clue I was being attacked, that there was a blindfold on me or an IV in my foot! My precious bride was feeling frisky and wanted to talk about fantasies, very new and different here. She wanted me to call her a black girls name which was totally out of character for her but in the light-hearted moment I came up with the most ridiculous one I could...probably faster than they planned. Yes, they! There was a team strategically trying to trick me. I sensed something was wrong, even in my heavily drugged slumber and became suspicious that I could see light in the corners of my peripheral vision. When I tried to pull the blindfold off, I found my arms were gently tethered with soft but strong bindings. The blindfold had to come off the get a seemingly incriminating photo and when it did, I was supposed to have my eyes closed. Instead, I was hollering and thrashing against the tethers until I was hit with an ether rag...unconscious again. My wife had been talking to me, but the woman on top of me was black; about the same size and shape as my wife, but...no.

Months later, I was able to recover the memory. After learning how Rohypnol works, I realized that the purps would most likely have used an underaged female in order to gain maximum control over me. The attack did not stop there. I was knocked out with an ether rag and another stage of the attack began with my wife proposing a conspiracy she really didn't understand. I couldn't understand why she was even interested in it. I was quite well-off, she was on pace to live a life of luxury. The financial reward for the "not quite right" (clearly felonious) racket might have been attractive to others but I was doing better honestly with nothing to risk not to mention forfeiting my eternal salvation! I was again able to realize I was restrained and pretended to be more drugged than I was to buy time and realize that my best option was to agree to cooperate and hope I could remember what I was reciting in my head when I recovered.

As I rewrite this to make it more understandable, please note that I've filed dozens of reports with every proper authority and set up dozens of videos on You-Tube under the name 357 Cletis. All have been taken down or buried by our corrupt media and law enforcement. Realizing that this might happen, I also burned hundreds of CD's with the same evidence and flung them out into lawns, newspaper boxes, etc all over Jackson and Barrow Co. GA. I even got a petty criminal charge for this at one point by someone complaining I set off their car alarm! The message in the name; read between the lines... 22 or CLETUS - See let us 22. This was the sign I used for the sting from the beginning, borrowing it from Psalm 22 which you will see I revisited many times. It was in response to the evidence they kept giving me which required understanding of something more, like from history. Something that I would understand but it would be one letter off or somehow obscured so you had to read between the lines. The spies knew that I would be able to follow clues, but they were leaving clues that were weak evidence at best. Still, they wanted me to understand. Prosecutors know better than anyone how to

avoid leaving admissible evidence. I wanted a public trial so that everyone could understand why I did what I did, which was not a crime.

I wanted to be able to explain how I had tried to get my bride to watch Atomic Shakespeare with me after giving her the very best I could, and taking away anything she didn't find suitable. I knew it was a compulsory right for any accused to explain themselves. At that point, I had been charged with a bogus domestic violence crime necessary for their racket. I didn't understand why they were so clearly pushing a criminal charge when all attorneys kept telling me I hadn't broken any law and there wasn't even an accusation that justified an arrest! I was fighting for visitation with my son, permission to rent my house and mitigate my new unjustified financial burdens. The action I was arrested over was profound and quite romantic but again a branch of this story that is not necessary. What is important to note is that I had been implementing a drama from Atomic Shakespeare, in response to my Brides' occasional shrewish behavior. This drama I learned from my Highschool English Teachers. When I learned who her (and her sisters') English Teachers were, I would discover the groundwork for how my mother-in-law became Yates transcription fixer. Mom had volunteered as room mother for the Chief Judges wife and from that began Stenography; nothing better than a good dependent friend to fix you're transcripts for your criminal organization!

important to note here, is that the Chief Superior Court Judge, David Motes, was her mother-in-law's former employer. Mom had been the stenographer for the previous criminal organization where our District attorney, Tim Maddison, went to prison. Mom kept her side job fixing transcripts for the Court Fraud but as far as I knew at the time, she was only fixing transcripts for the doctors her company served. I later discovered it was just a short walk through the woods between Judge Motes back door and the houses of my Mother and Sister-in-law. My sister-in-law married into the county Sheriff's family; she was the lead investigator at the time. All of these connections lubricate the wheels of corruption to pull off the financial heist Yates was pulling and shut down any one investigating the corruption. Remember Yates brother-in-law was the Chief of Police and county commissioner. He had also been the Principle of Jackson Co. High School where my mother in law volunteered in the office.

Ten years ago, before all the national news I refer to here, the average citizen would believe my story but thought it would sound a little far-fetched to someone from outside this judicial circuit. The locals didn't doubt it, they had seen enough! Today, nobody can deny that I made the reports I did before the national cases in the media surfaced. Fact of the matter, I knew the attack against me was not an isolated case. Mike Buffington, a local editor in Jackson county GA reported that multiple unrelated people contacted him to report that they experience the same style bizarre attacks. He cited a rare, high dollar sports car, the health elixir Yates was using, and a system of "favors" as common threads between the unrelated victims he spoke to. His reporting was silenced by the FBI and he told me he would not talk to me since the FBI was investigating. That was 12 years ago when Sally Yates was the ranking US attorney over the Southeast, seated in the North Georgia Richard Russell Federal Bldg. Squarely overseeing her family members, like her brother in law; the Chief of Police and county commissioner over Jackson county Jail where her children worked. This is the jail where I was held on bogus charges without bond or trial for nearly 4 years after setting up websites with dozens of videos of police corruption...including the kidnapping of my infant son.

The best way to stop someone from being attacked is to warn them, and very specifically in a case where the attack is crafted so slyly that it will ensnare rulers, as Epstiens' did. (Referring to Jeffery

Epstein and Ghislaine Maxwell.) I survived the attack, by the grace of God. It is waiting for anyone who seeks a position of power and is no doubt the cause for so many lawmakers who constantly make ridiculous decisions compromising our country. I'm not saying all corrupt politicians and bureaucrats have been taken hostage in this fashion. Truly, spies and government officials stand to be kings in a socialist government. There are other motivations for FBI, CIA, and NSA spies to sabotage democracy. I'm sharing the heinous attack against me in order to warn others and expose the spies who are doing it!

My ex-wife would hint at the corruption my mother-in-law was involved in and occasionally want me to meet someone she knew, then she didn't...she was struggling and was double minded. She would not tell me what she knew but made it clear that she knew how to "get me." What I didn't know was that she was struggling with a drug addiction and this ultimately led her to her resolve to join the racket. I was on the cusp of finding out that my infant son had autism, that she had hidden a long-term drug addiction, and used during her pregnancy. Her compromise led to the plot against me and no doubt the same plot that has led to so many of our lawmakers and bureaucrat's inexplicable behavior.

For a long time, even when again drugged with Rohypnol and cued "have you ever had sex with a black girl?" I had NO recollection of that attack. My first memories of the event were waking up, having to urinate, and feeling like a bee was stinging my foot. I scratched the gauze pad off of the top of my foot and noticed the excessive blood on the sheets around the area where the IV had been. I was barely able to make it to the restroom and back before falling into unconsciousness again.

Within roughly a year of that attack, I spent nearly 4 years in Sally Yates Family run jail without bond or trial; Yates' brother-in-law, and children trying to force me into the racket she set up. No, I wasn't charged with any sex crime. I was charged with a bogus domestic violence crime. See, the racket they planned was to hold me for years on a bogus charge and get a huge wrongful imprisonment settlement. If I didn't cooperate, they would no doubt be able to lock me up for the heinous crime they conducted against me! Since then, the legislature in GA has changed the law to make statutory rape a crime without any statute of limitations! In other words, if you were attacked in the fashion many have been, you would be a life-long slave to who-ever held the "evidence!" In my case, they had more problems, the photos they took were not incriminating. Others had accused Yates of similar attacks, and the other attempts they took to build the bogus case against me backfired. By the time they realized I was on to them they were facing accusations on multiple fronts and couldn't frame me without setting off alarms the other victims would hear. I had them good, but I couldn't prove it was Sally Yates and no authority would entertain investigating her. They had kidnapped my son, wrongfully arrested me and injured me in a manner that crippled my company... even my neighbors had called to report a heinous police attack against me with injuries. They again injured me, took me into custody, but had to release me without getting me out of the neighborhood because the massive police attack was reported by my neighbors.

After nine months of exposing numerous fraudulent police actions against me and multiple attacks from Yates' puppets I came up with a plan to sting them. I again used Psalms 22 to set up the sting as I knew they would be well versed at sting operations, but weak on the word of God. A counselor, who I was required to see to get visitation with my son, told me I had caught someone big and to think about what I wanted, that someone would approach me. I again honed my plan to show that I was going to conduct a sting and that it was known to net Sally Yates.

In classic fashion, God showed up to defend me...again. I again was drugged by a person I was suspicious of, in my home! They asked me what I wanted. I executed the sting I planned during that

attack. While there was no physical attack this time there was the gripping downward spiral I had been in for 9 months of police brutality, harassment, and sabotage. The group represented themselves through a puppet named David Lord (my home builder) with a video camera police shirt and an earbud. They were foolish to permit me no alternative to recovering my child, reputation, and company. He admitted to drugging me with Rohypnol in my beer at the instruction of the people on the camera button he motioned to. With no other option, I agreed, with multiple references to Psalm 22. This being the verse Jesus used to show anyone who was familiar with scripture that he was in fact the Son of God. A verse that would have a completely different meaning to anyone who was not a God seeker. I also incorporated a classic hook, "Mustang Sally of the Richard Russel Federal Bld" in a way that only someone in my Highschool class would recognize... but nobody else would pick up on. "There is a plan in place" I said to the crook that drugged me. "The guy who knows the plan has the key." My best hot Rod was to be kept by this unwitting fellow. Clearly, he didn't know the plan! I hadn't talked to him in many years. I saw him on face-book and asked what he was driving now...but never got a response.
